Your involvement can help your child feel more settled, which supports their wellbeing, education, and future. Knowing that you're okay can also ease their worries.

Even small gestures such as contributing to a birthday card or gift can mean a lot. If this is something you'd like to do, it's best to speak with the Special Guardian to find the right way forward.

What is a special guardianship order?

Special guardianship is a legal arrangement through a Special Guardianship Order, decided by the court. The person appointed to care for your child is known as a Special Guardian. They will care for your child in the event you are going through a tough time and are unable to care for them yourself.

The Special Guardian will have parental responsibility, which means they can make everyday decisions about your child's care, including things like schooling and healthcare. However, there are still some decisions that need your written permission and the court's approval such as taking your child abroad for more than three months, changing their surname, or applying to adopt.

We know that circumstances can change as children grow. If any changes to the SGO arrangement are needed, they would be decided by the court.

Assessment

To become a Special Guardian, the person must be assessed by a Social Worker to make sure they're suitable to care for your child until adulthood. This is all about making sure your child's needs will be met in a safe and loving environment.

The assessment looks at several things, including:

- how they plan to meet your child's needs;
- their thoughts and feelings about your child and the arrangement;
- what their own children (if they have any) think about the arrangement;
- what your child has experienced Information about you and your family;
- their own background and circumstances;
- · how they can support during Family Time; and
- how they will make sure your child is safe.

This process helps ensure your child is placed with someone who can offer them stability, care, and support as they grow.

Family time

Where children are looked after by a Special Guardian, arrangements for family time should be agreed during the care proceedings. Family time facilitates meaningful contact between children and their families.

The Special Guardian is responsible for making sure family time is safe and positive for your child. It helps when everyone treats each other with respect and sticks to the agreed arrangements, so things run smoothly.

If things feel strained between you and the Special Guardian, it might help to ask another trusted family member to support with making the arrangements.

We're currently developing additional support for birth parents to make family time a positive experience for everyone involved, and to reinforce the important role birth parents continue to play in their child's life wherever possible.
